Lakedale disclaims any and all implied warranties, including the implied warranty of merchantability and implied warranty of fitness for a particular purpose. Lakedale shall have no liability for special, indirect, or consequential damages arising from or relating to any services or facilities provided to me (regardless of whether such liability is claimed to exist on the basis of contract, negligence, or otherwise), including, but not limited to, lost profits or loss of business opportunity. Any liability of Lakedale shall be limited to the return of any one-time or recurring charges paid by me.

Agreement for High-Speed Internet Etherset Lease Program

This contract between the undersigned (Customer) and Lakedale is for the leasing of equipment (Etherset) length of commitment term. The undersigned (Customer) agrees to lease the (Etherset) for a minimum period of one or two years, (length of time determined upon initial application), from the effective date (period of time when service is temporarily suspended, by mutual consent, are disregarded). The effective date is defined as the date that service is successfully activated at the Customer's designated location.

Early Termination Fee: Customer agrees to pay a termination fee upon removing service before the length of Etherset Lease Agreement has been fulfilled. Contract for Waiver of High-Speed Internet Activation Charge

This contract between the undersigned (Customer) and Lakedale is for the provision of high-speed Internet service. The minimum period of service is one year from the effective date. The effective date is defined as the date that service is successfully activated at the Customer's designated location.

CUSTOMER OBLIGATIONS:

1. Subscribe to high-speed Internet service for a minimum period of twelve consecutive months from the effective date. Period of time when service is temporarily suspended, by mutual consent, are disregarded.
2. Timely remittance of payment in full for the high-speed Internet service provided.
3. Responsible for any wiring required beyond the Demarcation Point / Network Interface Device (NID).

EARLY TERMINATION FEE: Customer agrees to pay a termination fee in the event that any clause, as described above, is breached. The early termination fee equals the applicable activation charge of \$95.00 or \$251.00 without local phone service plus any prorated monthly charges for this service.

EXCEPTIONS. EARLY TERMINATION FEES DO NOT APPLY WHEN:

1. altering the bandwidth (speed) of the service, or
2. changing the designated location where the service is provided, or
3. moving between billing plans (i.e. a la carte vs. packages), or
4. Lakedale, in its sole judgment, is unable to meet its internal service standards.

COMPANY OBLIGATIONS:

1. Waive the \$95.00 or \$251.00 high-speed Internet activation charge as long as the Customer is in compliance with the terms of this agreement.
2. Provide and maintain the specified service in accordance with generally accepted industry standards.
3. Provide high-speed Internet service to the Demarcation Point / Network Interface Device (NID).
